

WORLD FLYING DISC FEDERATION

WFDF BOARD MEETING

Time: May 21th 1986 at 22:00 British time.

The meeting was held as a telephone conference.

Participants: Charlie Mead, (CM), Johan Lindgren (JL), Dan Roddick (DR), Andrew Morris (AM) and Brendan Nolan (BN).

Agenda: 1/ Opening, 2/ Formalities, 3/ Finance, 4/ WDGC prizemoney, 5/ Reports, 6/ Congress 86, 7/ GAISF, 8/ Rulebook, 9/ Committees, 10/ Logo, 11/ Tournaments, 12/ Records, 13/ Other topics, 14/ End.

1/ Opening: JL opened the meeting by telling the others that he had become a father to a baby boy the afternoon before. Congratulations from everyone.

2/ Charlie took over and said that he would be chairman of the meeting and JL secretary. CM also said that the speaking order would be the same on every issue in order to save time as much as possible.

3/ Finance: Brendan said wich countries had paid what: Finland 50, FPA 50, New Zealand 50, Netherlands 50, Denmark 25, Switzerland 50, Japan 50, Taiwan 50, Australia 25, Italy 125, USDS 125, Sweden 100, Wham-0 525. Thats a total of 1775 USD so far. Some of it has been used for mailings but most of it is still there.

The meeting decided that BN should find the treasurer of each associations and send reminders to those who hadnt payed yet. He should also each year send out bills for the annual fee to each association. He should also write to all sanctioned tournaments to remind them of the sanctioning fee.

4/ WDGC prizemoney in Helsingborg. JL could inform the meeting of the fact that the Swedish association finally had got the money together to pay all the prizemoney from the WDGC in Helsingborg. Those who had their sum delayed got a 10 percent interest on the money. DR says that the swedish association must be praised for really paying all the prizes though the tournament was such a big loss financially. He said that it was the first time an organizer had managed to pay delayed prizemoney. He himself could "retire" on prizemoney he was due from Santa Cruz. CM will draw up a sanctioning form and possible solutions for guarantees for prizemoney in tournaments.

5/ No special reports.

6/ The Congress is to be held 22-23-24 august 1986 in Colchester in conjunction with the Ultimate and Guts world championships that start on the 25th. CM has all the practical details organized. Apart from the Congress there will be a philosophical symposium on the wednesday the week after and a rulesmeeting open to everybody on the thursday. JL will contact Erik Hammer reminding him of his dutys a returning officer. All on the board are willing to stay on except CM who wishes to rest for a couple of years from frisbee. The topic of voting on the next Congress is discussed

and the board finally agrees on a proposition where the votingpower is devided into three levels: 1 vote, 2 votes or 3 votes. There should also be a similar level struc- ture on membership fees. It should be related to the number of members in the diffe- rent countries but exactly where the levels should be placed is impossible to say anything about before all the associations has answered the questionnaire in the newsletter 1/86. JL will write the proposition for the Congress.

The board also decides on a proposition to elect people on the board for several years on alternating years as a safety device against all members on the board beeing changed the same year eliminating all contiuity. The board also decides on a proposition on a change in the TRG making it up of one representative of WFDF (the rules committee), The tournament organizer, and the players. JL will write those proptositions.

CM likes to have noints about info and promotion of WFDF in the Congress.

7/ GAISF: JL gives a short report on GAISF of which the most is already published in the newsletters. DR and BN are hesitating about GAISF. They think it might steal too much time and money. AM says that we have lots to learn from GAISF and CM is comple- tely for joining GAISF. The board does not make any decision. The issue will be decided by the Congress.

8/ Rulebook. JL has spoken to Marko Timonen who has not done any work on the rule- book. So JL has compiled the material so it can be printed soon. It is decided that JL will have the material typesetted in Sweden and that Wham-0 will print it. It will be in the size of A5 and we will make about 1000 copies in the first run. DR will send one each to every association and the rest to JL for storing until orders drop in. It is decided to keep the round accuracy targets in the rulebook and ad- vising the americans to make a motion in the issue to the Congress.

9/ The committees. Only Ted Smethers in the golfcommittee has done any visible work. (The day after the meeting a report with new gutsrules came from Peter Turcaj in the Guts-committee.) JL says that maybe it is too much to have committees. Maybe it could be enough with one resonsible person in each field with the authority to work with any people he/she wishes. DR says that maybe the committees are not so good at all. Maybe it would be better with special tasks and vouluntary people taking responsi- biltie of performing those tasks. CM would like to keep the committees. it is too soon to drop them after less than a year. But they need specific duties and lots of support. No decision is taken. It will surely be discussed at the congress.

10/ Logo. A lot of suggestions has come in and AM has also distributed some suggestions. After a short discussion the board decides on the "A" suggestion from AM. See the end of these minutes. AM will make originals and send to JL, DR and CM. DR will produce discs. CM will produce t-shirts and JL will produce stationary. The logo will also be on the rulebook.

11/ Tournaments and sanctioning: There is only one bid for the 1986 World Disc Golf Championships and it is acceptable. It is the PDGA championship in Charlotte, USA july 23-26.

12/ Records: DR is appointed the official recordkeeper of WFDF.


13/ Other topics. JL has sent a short video to Screen sports in GB.

13/ cont. AM would like a videolist and both CM and JL promises to send one each. CM talks about the two Ultimate tournaments in Rotenburg and Belgium with an american team cleaning out. There had been some debate over the cost to participate in the worlds in England but CM explained the costs and way no cheaper alternative could be provided.

14/ The meeting is closed after a little more than two hours and all five participants think it has been a nice experience talking simultaneously with four others around the world.


Note: The cost was 4 500 swedish crowns and will be put on JL:s private phonebill. BN promises to send him the money immediately.

WFDF STATUTES

(As decided by the Congress in Helsingborg, Sweden 14-16 aug 1985)

ALTERATION OF THE STATUTES

=====

Proposals from the board:

§ 4:3 Each member association receive one, two or three votes at the Congress depending on the number of members in the association.

Explanation: The WFDF-board feels that in view of the big span in size and organisation between the members in WFDF it is warranted to have different levels of voting. But there is no suggestion to where the levels of votes should be. The problem is that very few associations has answered the questionnaire and as long that is not done it is hard to place any suggestions to where the levels should be placed. As any statute this one can be changed in the future if the situation changes.

§ 4:8 10-13 The president should be elected each year but treasurer, secretary and the two additional board-members every second year alternating.

Explanation: With the present system the whole board could be new one year leaving no continuity at all. By electing the boardmembers for two years alternating WFDF will always have at least two boardmembers staying on. Our suggestion is that we this year elect either the secretary or treasurer and one of the board-members for two years and the other two for one year. Next year we elect the positions elected for one year now for two years and we have got it rotating. The president will always be elected.

§ 8:4 The RUC shall be represented at all world flying disc championships and together with one representative of the players and one representative of the organizer form a Tournament Rule Group (TRG).
(The rest of § 8:4 as it stands.)

Explanation: The board feels that one representative of RUC and two of the players is wrong. The TRG should consist of one representative each from WFDF, the players and the organiser. In that way no group is in majority and the TRG:s decisions will be a lot more representative.

1:0 ORGANISATION

1:1

The World Flying Disc Federation (WFDF) unites and represents flying disc associations world wide.

1:2

WFDF is an impartial governing body that has no commercial links with any one manufacturer or retailer of discs or disc-associated products.

1:3

The supreme body of WFDF is the Congress, either regular or extra. The federation is directed by the WFDF-board, assisted by the committees.

1:4

Official publication is the WFDF-newsletter.

1:5

Financial year is from april 1 to march 31.

2:0 AIMS

2:1

To encourage and protect the SPIRIT of flying disc play where as partners rather than opponents we compete against the limits of our own abilities rather than each other. Where in a climate of peace disc play may be appreciated for its ability to bring people together in a communal rejoicing of skill and play. "Ultimately, in playing together we learn to live together".

2:2

To encourage disc play throughout the world and promote the establishment of new national flying disc associations, advising them on all flying-disc activities and general management.

2:3

To achieve general acceptance of disc play as a sport.

2:4

To provide a forum for discussion on all aspects of disc play worldwide and to arbitrate between flying disc interests when and where conflict might arise.

2:5

To establish and uphold a tournament standard for all flying disc competition worldwide. To fairly distribute the right to organise World Flying Disc Championships to interested associations and to sanction other international tournaments.

3:0 MEMBERSHIP

3:1

Members of WFDF are national flying disc associations which pay the current membership fee and follow the statutes of WFDF.

3:2

To become a member of WFDF an association has to apply for membership in writing to WFDF, submitting documents covering the associations statutes, organisation, activities, members, economical status and possible official recognition.

The application is decided on temporarily by the WFDF-board and finally by the Congress. To be accepted as a member the associations statutes and work must not contradict the statutes and aims of WFDF.

3:3

A member association which violates the statutes of WFDF or in any other respect is working against the development of flying disc play can be expelled from WFDF by the Congress.

If the violation is severe the WFDF-board can suspend the association until the next Congress.

3:4

A member association which may wish to leave WFDF must state so in writing to the WFDF-board submitting a protocol stating the decision of a meeting with jurisdiction in the matter.

4:0 THE CONGRESS

4:1

The WFDF Congress shall be held every year in connection with the World Flying Disc Championships. If they are separated by time

and/or distance a place shall be chosen by the WFDF-board.

4:2

At least 6 months before the Congress each member association shall receive an invitation to the Congress with information on where and when the Congress will be held and where to send motions for the Congress.

At least 4 months before the Congress the motions from the member associations shall be sent to the WFDF-board.

At least 2 months before the Congress each member association shall receive complete material for the Congress, including agenda, the annual reports, statutes, proposals and motions.

4:3

(The writing of this statute covering voting power at the Congress will be decided on at the next Congress.)

4:4

All votes are taken by open voting unless any representative demands ballot voting.

All votes shall be done by an absolute majority of the given votes.

4:5

All representatives have the right to speak and make suggestions at the Congress. Only those associations that have payed their membership fees before the end of march before the Congress can vote at the Congress. A member association can proxy anyone they wish to be their representative. A representative can only hold one vote and has to be present to vote.

4:6

The Congress shall form a quorum with the number of associations that attend, provided that the Congress has been summoned according to the statutes.

4:7

Any board and/or committee member, also being a voter at the Congress, can not vote on freedom from responsibility, election of auditors or questions concerning his/her past work. Such representative may pass his/her vote in that question to an other nonvoting representative.

4:8

At the Congress the following points shall be on the agenda:

- 1/ Opening.
- 2/ Participation and votinglist.

3/ Has the Congress been summoned according to the statutes?

4/ Election of chairman for the meeting, secretary for the meeting and two officials for counting votes and signing minutes.

5/ Alteration of the statutes (Only at regular Congress).

6/ Annual report.

7/ Annual financial report.

8/ Auditors report.

9/ Question of freedom from responsibility for the WFDF-board.

10/ Election of president of WFDF until the next Congress.

11/ Election of treasurer of WFDF until the next Congress.

12/ Election of secretary of WFDF until the next Congress.

13/ Election of 2 additional members of the WFDF-board.

14/ Election of 3 ranked deputys.

15/ Election of 2 auditors + 1 deputy auditor.

16/ Election of a returning officer + 2 additional members of the election committee (ELC).

17/ Election of a Rules Committee (RUC). 3 persons of which one is elected chairman.

18/ Election of a Minority Interests Committee (MIC). 3 persons of which one is elected chairman.

19/ Election of an Ultimate Committee (UC). 3 persons of which one is elected chairman.

20/ Election of a Guts Committee (GC). 3 persons of which one is elected chairman.

21/ Election of a Disc Golf Committee (DGC). 3 persons of which one is elected chairman.

22/ Election of a Field Events Committee (FEC). 5 persons of which one is elected chairman.

23/ Election of a Freestyle Committee (FSC). 3 persons of which one is elected chairman.

24/ Decision on membership fees and other fees.

25/ Plan of action for the coming period.

26/ Budget for the coming period.

27/ Proposals.

28/ Motions.

29/ World Championship cites (Only at regular Congress).

30/ Appointing honorary members (Only at regular Congress).

31/ Closing of the Congress.

4:9

Eligible for election on points 10-14 and 16-23 are members of member associations, at least 20 years old and not employees of WFDF. Eligible for election on points 15 and 16 are persons, at least 20 years of age, not

employed by WFDF and not elected to any other position in WFDF.

4:10

An extra Congress shall be summoned within 6 months if the WFDF-board, the auditors, or at least 2/3 of the voting power of the member associations demands so in writing to the WFDF-board. The extra Congress shall in all respects be treated as a regular Congress except that the statutes may not be changed, honorary members may not be appointed and sites for World Flying Disc Championships may not be changed unless the responsible association no longer want the tournament.

5:0 THE WFDF-BOARD

5:1

The WFDF-board is the executive body of WFDF. It shall meet at least twice a year. It must abide by the mandate it was given by the Congress, but may make decisions in new matters that arise, with the aims as guide.

5:2

It shall control the work of the different committees and if necessary form new committees if new areas of activity are started. The committees are responsible to the board.

5:3

The WFDF-board is summoned by the president, or if at least 2 members of the the board demand so in writing. The board shall form a quorum when at least half of the members are present.

5:4

The board shall produce a WFDF-newsletter and in all possible ways spread the information about disc-activities. It shall make a list of adresses of WFDF-officials and distribute that list.

5:5

The board shall keep control of money acquired and try to acquire more money for WFDF. In no way shall the organisation's independence be violated. The board shall distribute the acquired funds according to 10:5.

5:6

The board shall summon the member associations to the Congress and prepare the material for the Congress according to the statutes 4:0 ff.

5:7

On the board the president and the treasurer are entiteled to allocate, each individually, sums not exceeding the equivalent of USD 1,000. Above that sum, both have to sign. An additonal limit is that they can never, alone or together, allocate more than 50% of the total funds of WFDF.

5:8

The board may co-opt any persons(s) it sees fit.

5:9

The board shall recieve bids and decide on the siting and sanctioning of different international tournaments.

6:0 THE WORKING COMMITTEE

6:1

The working committee consists of the president, the treasurer and the secretary. They shall meet and communicate as often as necessary, and possible, to keep the everyday-work moving. It shall make decisions in matters that arise between board-meetings. Such decisions must be unanimous and be reported to the next board-meeting.

7:0 MINORITY INTERESTS COMMITTEE (MIC)

7:1

The Minority Interests Committee (MIC) shall work in all aspects of disc play, looking after the special interests of the minority groups of WFDF.

7:2

It shall promote minority play with the aim of increasing the number of players in those groups.

7:3

MIC must cooperate with the board if suggestions for the minority groups are contradictory to the statutes, rules, or decisions of the board.

8:0 RULES COMMITTEE (RUC)

8:1

The Rules Committee (RUC) shall with the aid of the different event-committees prepare and sustain the rules of flying disc sports, and regulations for flying disc tournaments. New rules are to be published no later than January the 1 to be in operation from April the 1.

Copies of the WFDF-rulebook shall be sold to cover the cost of producing it.

If any member association wishes to translate the rules into its own language it must notify the board and supply a finished copy. Member associations are allowed to add national rules and regulations so long as the the WFDF-rules and regulations are not altered or contradicted.

8:2

The RUC shall no later than January the 1 produce a list of discs acceptable according to the disc regulations in the rules. Manufacturers of disc on this list may acquire the right to use this in their commercial promotion if they come to an agreement with WFDF.

8:3

The RUC shall no make their own suggestions on rulechanges. Such suggestions shall come from the different eventcommittees or a member association.

8:4

The RUC shall be represented at all World Flying Disc Championships together with two elected representatives of the players to form a Tournament Rule Group (TRG).

The TRG shall act as a jury for the tournament and shall arbitrate and make decisions which are binding on all rulesquestions during the tournament.

9:0 THE EVENT COMMITTEES

(UC,GC,DGC,FEC and FSC.)

9:1

Their general task is to look after and develop their respective events. They shall together with RUC revise the rules and be represented at their respective World Flying Disc Championships.

9:2

The Ultimate Committee (UC) and Guts Committee (GC) shall be responsible for their respective events and cooperate if any new teamrelated flying disc sports should develop. Both committees shall make suggestions for possible sites for their world championships, and be represented at those world championships.

9:3

The Disc Golf Committee (DGC) shall make suggestions on possible sites for World Disc Golf Championships. It shall work for the development of international golf tours, both professional and amateur in all divisions. It shall co-operate with FEC about overall world championships. It shall develop a standard for disc golf courses and make a catalogue of courses that meet that standard. It shall be represented at WDCG.

9:4

The Field Events Committee (FEC) (i.e. Accuracy, Discathon, Distance, Double Disc Court and Self Caught Flights) shall together with DGC and FSC make suggestions for the siting of the overall world championships. It shall be represented at these championships. It shall also be consulted when bids for separate event world flying disc championships are made. FEC shall also promote individual play and try to have other international overall tournaments organized.

9:5

The Freestyle Committee (FSC) shall work with FEC on overall world championships. FEC shall also promote separate international freestyle tournaments and world championships and be present at those championships. FEC shall also try to develop and encourage freestyle shows in appropriate forums to help the fulfilment of the aims of WFDF. FSC shall develop routines for performing and judging freestyle and these suggestions shall be put forward to RUC.

9:6

All committees shall follow the aims and statutes of WFDF. They shall report to and follow the decisions of the WFDF-board. All committees shall submit material to the newsletter.

10:0 FINANCE

10:1

Each member nation shall, before the end of March each year, pay the fee for the coming year. The fee shall be decided on by the Congress. If the fee is decided to be member-related or in some other way constructed to be different for different member associations, then the association joining during a year will only have to pay the lowest fee for that first year.

10:2

There shall also be a fee for the right to organize a world championship. The fee shall be decided on by the Congress.

The association organizing a world championship shall no later than 1 month after the championship send the fee to WFDF together with a summary of the tournament including accounts, results, names and addresses of all competitors, media coverage and possible comments.

10:3

Anyone who wishes to organize an international flying disc tournament may have that tournament sanctioned by WFDF. In order to have it sanctioned the organizer has to apply for sanctionship well in advance of the tournament and then pay the sanctioning-fee before the tournament starts. The sanctioning fee is decided by the Congress. Sanctioning means that the tournament is taken to the list of sanctioned tournaments of WFDF and that records achieved during that tournament are official. If the application for sanctionship is made in time the tournament will also be advertised in the newsletter.

10:4

The WFDF-board shall also authorize the production of materials such as the rulebook, a newsletter, videos and other saleable objects in order to acquire money for WFDF.

10:5

All money shall be used in accordance with the approved budget.

11:0 TOURNAMENTS AND CHAMPIONSHIPS

11:1

There should be world flying disc championships in all events and an individual overall championship each year. Associations wanting to organize a world championship shall make a bid for that championship to WFDF.

The bid must show a valid outline for the championship containing dates, costs, facilities, participation limits and how that championship will be run.

The bids shall be reviewed by the board and the respective committees. Final decisions are made by the Congress.

11:2

Minimum standard at world championships are:

- accommodation in beds with 4 persons/room maximum,
- breakfast and dinner,
- player kit (disc + t-shirt),
- field standard and availability according to the rules,
- medical care.

The minimum standard is subject to the discretion of the Congress.

Organizers of sanctioned tournaments shall also try to follow the minimum standard.

11:3

For every WFDF world flying disc championship there shall also be a back-up organizer appointed if possible. If the original organizer can't have the championship it shall be given to the back-up organizer.

If an entirely united WFDF-board decides that an association about to organize a world flying disc championship has severely neglected its duties and it is apparent that the championship will fail, then the championship shall be given to the back-up organizer. The WFDF-board must ensure that every member association, but especially the original organizer, is immediately informed of any change.

11:4

All world flying disc championships must be played according to the valid WFDF rules. Any supplement the organizer of a championship may wish to use must be in the outline of that championship put forward to the Congress.

Any changes the players or captains meetings wish to make must be approved by the Tournament Rule Group (TRG).

11:5

To represent a nation in a world flying disc championship a player must be of that nationality or have lived there for at least one year prior to the championship. The timelimit is subject to appeal to TRG.

11:6

Apart from the world flying disc championships outlined above the committees shall encourage display and discompetition at all levels, especially in areas with no tradition of disc sport.

11:7

All officials of WFDF have free access to all world flying disc championships and sanctioned tournaments. This does not include the cost for lodging, food, travel etc.

12:0 RECORDS

12:1

The WFDF shall recognise records in the following events: Accuracy, Distance, MTA and TRC, in the following divisions: Open, Women, Juniors (≤ 18), Under 12, Masters (35-44), Grand Masters (45-54) and Senior Grand Masters (55+).

12:2

In order for a record to be valid it has to be achieved at an international tournament organized or sanctioned by WFDF or at a national tournament organized and sanctioned by a member nation or at an european tournament organized or sanctioned by EFDF. The WFDF rules must have been used at the competition.

The information about a new record must be sent to the WFDF-board as soon as possible. This must be done on a Flying Disc World Record report form, which must be completely filled out and accompanied by evidence that the tournament was properly organized or sanctioned.

12:3

The WFDF-board shall regularly, not less than twice a year, publish and distribute lists of the present world records to the member associations.

12:4

If the WFDF-board does not accept a record the player's national association can appeal to the Congress.

12:5

If any member association disagrees with any new record it can also appeal to the Congress.

13:0 ALTERATIONS OF THE STATUTES

13:1

These statutes can only be changed at a regular Congress with an absolute majority of the given votes.

13:2

Motions on alterations must be made at least 4 months before the Congress and proposals to alterations at least 2 months before the Congress.

13:3

If there is any doubt about the meaning of any statute, or if a new matter arises that is not covered in the statutes, the question must wait until the next Congress. If the matter is urgent the WFDF-board may take a temporary decision.

14:0 WINDING UP

14:1

The WFDF can only be dissolved by two consecutive Congress' of which one must be a regular Congress. This decision can only be taken by a vote of 2/3 majority each time. There must be at least 6 months between the two Congress'.

14:2

If the WFDF is dissolved its assets shall be sent to the United Nations work for children.



YEARLY REPORT
=====

Since the first Congress in Helsingborg, Sweden in 1985 the board has held one meeting. Due to financial resources it was only possible to meet over the phone but it was done as a telephone conference were all five boardmembers could speak and listen at the same time. A nice experience all five said afterwards except maybe Andrew Morris who had to get up at three o'clock at night.

During the meeting the board decided on several things the biggest being a decision on a logo and sanctioning of the PDGA golf championship as the World Disc Golf Championship of 1986. See the meeting minutes at the end of this newsletter for the details.

The board has distributed three newsletters and a couple of shorter messages. It has tried to collect the information the last Congress demanded but have met trouble getting the associations to answer.

The rulebook has been printed but late. See the letter from Marko Timonen later in this newsletter. If you have not got the rulebook yet you will get it any day.

The board has developed a contact with GAISF (General assembly of international sports federations) in order to investigate the possibilities of WFDF joining GAISF. See further details under that point in the agenda.

Some of the committees has produced suggestions for the rulescommittee. The golf committee has produced suggestions for a course listing and a WFDF world disc golf tour.

The board has investigated and informed the involved of the delayed payment of pricemoney from the golf tournament in Helsingborg. Eventually the swedish association payed all the money with a ten percent interest for those who had to wait.

The above is only an aproximative financial report. Brendan Nolan will distribute the exact one before the Congress together with the auditors report. Since we are dealing with different currencies at different times on two bank accounts, one in Ireland and one in Sweden it is hard to do an exact balance. The printing of the rulebook will also cost money but that bill has not come yet. As you can see a lot of countries has not payed yet. If youre not on the list please pay or your representative will not be allowed to vote in England.

PLAN OF ACTION

=====

A lot of what the WFDF should be doing the coming year is depending on the decisions by the Congress. Vaguely one can say that one of the prime duties for the board is to really get WFDF known on the field and telling the players what WFDF can do for them and what they can do for themselves by supporting WFDF. As Dan said on the board-meeting: "The player must be able to identify WFDF in some way".

The work on the rules must continue. The board must actively try to find organisers of world championships. The organisation and the paperwork must be even more firmly structured and the member associations be more supported.

And all this is only possible if all the disc associations of the world support WFDF and supply WFDF with funds and information.

BUDGET

=====

This is even more hard to predict. The membership fees will change. Will Wham-0 give any support? Will the rulebook cover its own cost this year? How much will the championships bring? What will the selling of discs and shirts bring?

As you can see this years fees was spent on mailings and one boardmeeting by telephone. It is expensive to have things done even though a lot is free. Wham-0 is printing the rules. The swedish association has printed all newsletters free and is paying the typesetting of the rules until WFDF has the money to pay that bill.

If you figure that the membership fees will increase some you could expect maybe USD 1000 there. The worlds in England should bring around USD 3000 and the world golf in Charlotte maybe USD 200. The selling of discs and shirts should also bring some. Lets say 800. Then there are an income of USD 5000. With some more boardmeetings, some increase in mailings and the costs for the Congress (hoping that the rulebook will at least cover itself) it would leave about USD 2000 for new initiatives.

GAISF (PROPOSAL)

=====

GAISF stands for General assembly of international sports federations and the majority of the international sports federations are members. We can also become members if we want to. But it costs - several thousand Swiss francs per year to be a full member. There are also lower and cheaper levels of membership. We fill the formal requirements to become members and our statutes are very similar to those of GAISF. If we apply for membership it is not certain that we acquire full membership from the beginning. The benefits from being a member of GAISF is official recognition for WFDF and the possibility of frisbee being an event in the world games which take place the next time 1989 in Frankfurt. GAISF also have olympic sports as its members so being a member of GAISF is not in any way stopping our possibilities of becoming an olympic sport.

The board has no proposal in the GAISF-matter. There were different opinions within the board over the GAISF-matter some pro and some con so the matter is completely open for discussion on the Congress.

INFO (PROPOSAL)

=====

The board feels that the issue of info and promotion of the WFDF should be discussed at the Congress. The opinion of the board is that WFDF has to be more commonly known among all disc-players of the world but how do we do it and how much can it cost.

MEMBERSHIP FEES

=====

At the last Congress we decided on a minimum membership fee of USD 25. For this Congress the board has proposed a three-level-voting structure and therefore also suggests a three-level-fee structure. Exactly where those levels should be is hard to suggest of the same reasons as you can see under the voting suggestion. The associations has not answered the questionnaire. One can assume that the "poorest" associations would like to keep the lowest level at USD 25. Maybe you could place the others at 50 and 100. That's about how the situation has been this year.

MOTION NO 1

=====

The swedish association motions that the WFDF congress decides that world championships are only played every second year alternating with the european championships wich also should be played every second year. We suggest that the europeans are played on odd years and the worlds on even years.

MOTION, NO 2

=====

The swedish association motions that the WFDF congress decides on uniform rules for sponsoring and advertising. The swedish annual meeting has decided on such rules for Sweden. It is two pages regulating the relationship between association, organisers and players were sponsoring is concerned. A shortened version follows:

- A/ Covers advertising on tournament equipment, how the advertising shall be done and things that cannot be advertised like drugs, sex politics etc.
- B/ Covers who has the right to advertise on the players in which sorts of tournaments. For example the swedish association has the sole right to sell advertising on the clothes the players are to wear when playing on the swedish national team, but in the swedish championship the teams competing must have a defined blank space on their shirts if the swedish association finds a sponsor for that championship. In the same way the WFDF congress could decide that all national teams would have to put advertising on their clothes if the sponsors of a world championship demanded that, as you could see during the world icehockey championship this winter were all players had "AGFA" on their arm.
- C/ Covers who has the right to sign sponsoragreements for different types of tournaments.

The rest covers some details like: Advertising on and around the field shall follow the regulations of EBU and how to solve any disputes.

(PROPOSAL) MOTION NO 3

TO: WORLD FLYING DISC FEDERATION
FROM: WILLIAM TULIN
RE: THE CREATION OF A PUBLIC RELATIONS COMMITTEE

INTRODUCTION

If discs sports are going to grow in the future, then a certain amount of money will be needed for the increasing organizational expenses. The future creation of this financial support will come from the people of our respective countries. If the people are not aware of what our sport has to offer, then future financial support is put in a precarious position. Accordingly, the World Flying Disc Federation needs a centralized public relations committee responsible for the world-wide dissemination of disc news to both the broadcast and print media. The creation of the public relations committee would allow organizers of World Flying Disc Federation sanctioned events to receive help in acquiring local, national and world coverage of their event.

LOGISTICS

I propose that the Board of Directors and all committee members of the World Flying Disc Federation have at least two formal votes on this issue. One to decide whether a committee of this nature should be created in the first place; a second to accept a final plan of how best to set up the committee.

I would propose that at a minimum at least one Northern American Publicity Director and at least one European Publicity Director be established to oversee public relationship operations in their respective regions. Each regional director should have at least one assistant director. I would further propose that the long term establishment of the size the committee remain flexible so as to account for circumstances in the future.
